CONSTITUTION OF THE STUDENT CHRISTIAN ORGANIZATION OF MALAWI

PART 1: PRELIMINARY

Name and Address 01. (a) The name of the Organisation shall be STUDENT CHRISTIAN ORGANISATION OF MALAWI, hereinafter referred to as the 'ORGANISATION' in brief "SCOM Constitution.

- (b) The Constitution shall be referred to as "Constitution of the Student Christian Organisation of Malawi", in brief SCOM Constitution.
- (c) The registered office of the organization shall be situated in Lilongwe, Malawi.
- (d) The postal address of the organization shall be Post Office Box 657, Lilongwe.
- *Patron 02.* (a) The Patron of the Organisation shall be elected by the National General Council as its Annual General Meeting.
 - (b) Within 30 days of the election, the National Executive committee shall notify the proposed Patron in writing who shall also consent in writing.
 - (c) The Patron shall hold office for a period of five years, after which he/she may be re-elected.
 - (d) The Organisation shall not be obliged to have a Patron

(e) The Patron, if appointed shall reserve Honorably and Advisory capacities with public relational and promotional functions.

Interpretation 03. In this Constitution, unless context otherwise requires:

"**Organisation**" shall mean the Student Christian Organisation of Malawi;

"Constitution" shall mean the Constitution of the registered Trustees of the Student Christian Organisation of Malawi;

"Council" shall mean the National General Council;

"**Executive Committee**" shall mean the National Executive Committee of SCOM as established under Section 09.3 of the Constitution;

"Student" shall mean any person studying at any of the post-primary institutions in Malawi;

"Bible" shall necessarily mean both the Old and New Testament of the Holy Bible;

"Scriptures" shall mean the Word of God as written in the Bible;

"Statement of Faith" shall mean the statement of faith established under Section 07 of the constitution;

"Member" shall mean member of the organization in terms of Section 07 of the constitution;

"Church" shall mean the world wide Church of believers in the Lord Jesus Christ as Messiah, Lord and coming Judge of the world.

"Denomination" shall mean any denomination of any Christian congregation;

"Jesus Christ" shall mean as portrayed in the Bible;

"Men/Man" shall necessarily include women/woman;

"General Secretary" shall mean the employed Chief Executive at the national secretariat of the organization.

"Associates" shall mean any elderly Christian friend who loves Jesus Christ and is interested in working with students in the organization and support the organization.

"Senior friend" shall mean any non-student Christian who is interested in working with Students at a particular institution and has been officially attached to the institution by the organization.

"Section" shall mean the University and Colleges' Section of the organization;

"Region" shall mean any of the three regions of Malawi;

"Branch" shall mean a group of Christian students operating under the organization at a particular institution;

"**Employed Staff**" shall mean persons on a regular paid up contract with the organisation;

"Voluntary Staff" shall include all the associates and senior friends;

"Moral Standards" shall mean standards as determined by the Bible.

"Trustees" shall mean the registered trustees of SCOM;

"Fellowship" shall mean the SCOM-Associates Fellowship; **"Zone"** shall mean a local group of the SCOM-Associates Fellowship established under section 08 (a); **"National Committee"** shall mean the National SCOM AF

"National Committee" shall mean the National SCOM-AF Committee as established under section 11.6;

PART 11: OBJECTIVES, STATEMENT OF FAITH AND POWERS

Objects of the
Organisation04.The organisation shall be non-profit making ecclesiastical and
interdenominational organisation whose objectives shall be:

- (1) To call all students to personal faith in God the Father, the Son and the Holy Spirit according to the Scriptures, and to a life of union with Jesus Christ through the power of the Holy Spirit.
- (2) To deepen the spiritual life of students through prayer, study of the Holy Scriptures as the Word of God and the true record of God's revelation of Himself to man, and worship.
- (3) To help Christian students to witness for Jesus Christ in and out of school or college, and by study and discussion, fulfill their Christian vocation by living as His true disciples.
- (4) To bring Christian students into Christian fellowship with each other in serving the needs of all students and of the wider world.
- (5) To call Christian students to work for the unity, renewal and extension of the church in Malawi and throughout the world, and to encourage them to be responsible members of their particular church denominations, in obedience to the Lord Jesus Christ.

Statement of 05.In fulfilling its objectives, the organisation shall be guided by the
following statement of faith:

- (1) There is one God who is the Holy Trinity of the Father, Son and Holy Spirit. (Matthews 28:19)
- (2) God created everything that there is out of nothing; and all that He created was good. He continues to care for what He created (Genesis 1:1-10)
- (3) God created man in His own image, giving him authority over the earth. (Gen 1:27-28) However, man rebelled against God in cooperating with Satan. (Genesis 3: 1-7).

- (4) Even though all men have sinned, God loves men with an everlasting love, and has sent His own Son Jesus Christ to save man (Romans 5:6; 1 Timothy 1:15) Jesus Christ though being truly God, became real man and died for our sins. He rose bodily from the grave, never to die again, and ascended to heaven (Acts 2:23). He thus brought us new life, so that in fellowship with Him we receive salvation. (1Thess 5:9).
- (5) From Heaven, God sends His Holy Spirit upon man to convict man of sin, righteousness and judgment leading to repentance, rebirth and faith (John 16:8). By the Holy Spirit God seals all believers, calls them into fellowship with Himself and one another I His Church, and seeks to fill them daily (Ephesians 1: 13; 5:18).
- (6) God commissions believers to take His Gospel in love and service and make disciples of men (Matt. 28:19-20).
- (7) God has given us the Bible, which is inspired and infallible word of God and hence inerrant, the only true record of how He has created and saved us in Christ Jesus, and is the final authority in matters of faith and conduct (11 Timothy 3: 15-17; 11 Peter 1:16, 19:21)
- (8) At God's appointed time, Jesus Christ will come again in power and great glory to judge all men and bring into fulfillment salvation for those who trust Him, and condemnation to hell for those who do not. (Matt 24:30 -31)

Powers of the 06. Subject to the general and specific directions of Trustees, the organization shall be a body corporate with perpetual succession common seal and powers to:-

- (a) Open and/or lose any branch or branches of the organization at any of the institutions in Malawi;
- (b) Raise funds by the way of borrowing, donations or gifts of money or other property from any person or institution for the furtherance of its objects;
- (c) Employ any person or body corporate upon such terms or conditions and remuneration as the organization may consider necessary;
- (d) Where necessary, establish sub-committees and appoint members to assist the organization in carrying out any of its functions;
- (e) Print, publish, issue or circulate any information, report, periodical, book, pamphlet, leaflet or other materials relating to the organization;

- (f) Legally and administratively represent the interests of its members before any legally-instituted authority;
- (g) Invest and deal with any of its money not immediately required in any securities in such manner as the Organisation may deem feet;
- (h) Acquire, lease, hold, maintain, develop, let, sell, mortgage, exchange or dispose of property whether real or personal, movable or immovable, and generally deal with its property in any way the Organisation may deem necessary;
- (i) Generally, do all such lawful things as may be required for the attainment of the objects of the Organisation.

Powers of the 07.(1)Subject to the General and specific directions of the NationalSCOM AssociatesGeneral Council, the fellowship shall be a support wing of SCOM,
made up of interested mature, non-student Christians with powers to:

- (a) Open and/or close any zone or zones of the Fellowship in any area in Malawi.
- (b) Raise funds by way of borrowing, donation or gifts of money or other property from any person or institution for the furtherance of its objects;
- (c) Where necessary, establish sub-committees and appoint members to assist the Fellowship in carrying out any of its functions;
- (d) Print, publish, issue or circulate any information, report,, periodical, book, pamphlet, leaflet or any other materials relating to the Fellowship and the Organisation;
- (e) Invest and deal with any of its moneys not immediately required in any securities in such manner as the Fellowship may deem fit.
- (f) Generally, do all such lawful things as may be required for the attainment of the object of the Fellowship and the Organisation;
- (2) All Associates shall necessarily subscribe to SCOM aims and statement of faith.

- (c) Secretary,
- (d) Vice Secretary,
- (e) Treasure
- (f) Vice treasurer,
- (g) Bible Study Co-ordinator,
- (h) Prayer Co-ordinator, and two committee members, all of whom shall be students, General secretary as ex-officio.

 - (d) They shall subscribe to both Aims and the statement of faith of the organization.

(e) They shall be members of the organization, a member of the associate fellowship, a senior friend or member of an organization with which SCOM has good working relationship.

(b) Members of the sectional, regional and Zonal committees shall hold office for two years, after which they may be re-elected once.

(c) Student members who lose their student status through graduation or otherwise should be replaced at the annual general meeting by other students.

Elections for 12.5 (a) The branch committees shall be elected by members of that particular branch at the branch at the branch's annual meeting.

(b) Members of the branch committee shall hold office for one year, after which they may be re-elected provided that such candidates have at least another year before completing the course.

PART IV: OPERATION

Powers and13.Subject to the general and specific direction of the Board of Trustees
and to any rules made by it, the National General Council shall be
the highest policy making body, whose powers and functions shall
be:

- (a) To manage the Student Christian Organisation of Malawi under its jurisdiction to the best advantage.
- (b) To be responsible for the spiritual needs and growth of the organisation's members.
- (c) To approve appointment and dismissal of staff for the promotion of the organisation's objectives.
- (d) To ratify appointment in the National Executive Committee made in between General Council meetings.
- (e) To elect and dissolve a National Executive Committee in the interest of the organization
- (f) To raise support for the promotion of the organisation's objectives.
- (g) To control in the financial expenditure of the organisaion
- (h) To appoint Auditors and legal advisers of the Organisation
- (i) To advise and seek advice from the Trustees Board on all matters affecting the running of the organisation.
- (j) To maintain good working relationships with all parties concerned, without loss of vision and / or divine calling.
- (k) To affiliate and disaffiliate the organization to / from any other institution and organization
- (1) To represent the interests of the organisation's members before legally instituted authority.
- (m) To amend the constitution.
- (n) To appoint or dismiss Trustees.
- (o) To approve the audited accounts.

- (p) To appoint and dismiss Patron.
- (q) To dissolve the SCOM Associates Fellowship.
- (r) To dissolve the National General Council.
- (s) To decide upon the general policy of the organization.
- (t) To issue rules/instructions as may be considered necessary for the furtherance of the organisation's objectives.

Powers and14.Subject to the general and specific directions of National GeneralFunctions ofCouncil, the National ExecutiveCommitteeNational Executivepowers to perform on behalf of the National General Council the
following functions:-

- (a) To manage the assets and liabilities of the organisation on behalf of the National General Council.
- (b) To implement policies of the National General Council.
- (c) To ensure that the Council is represented at all Trustees Board Meetings through the persons of the Chairpersons and the General Secretary.
- (d) To maintain the integrity and the calling of the organisation.
- (e) To propose to the National General Council, the appointment and dismissal of the General Secretary and Training Secretaries; and appoint and dismissal all other staff.
- (f) To be responsible for the welfare and discipline of staff, whether full time or voluntary.
- (g) To make proposals of appointments in the National Executive Committee either in place of or in addition, for the National General Council's approval.
- (h) To assist in the selection of or propose suitable sites and /or premises for operation or facilitation of the operation of the organisation.
- (i) To initiate, facilitate or supervise all infrastructure development.

Meetings of 20. (a) The National General Council shall meet at least once a year at such specific venues and times as deemed convenient to members, one of which shall be the Annual General Meeting.

- Such meetings shall be preceded by written notice given at (b) least fourteen days in advance.
- (c) In addition to members of the organization, interested persons and organizations may be invited to annual General Meetings as observers.
- The quorum for such a meeting shall be half of the (d) membership. In the event that a quorum is not formed after sixty minutes from the advertised time, the meeting shall stand adjourned for four weeks; and if the quorum is not formed by then, the members present shall form a quorum.
- The Chairperson shall preside over all meetings. In the absence (e) of the Chairperson, the Vice Chairperson shall preside over the meeting; and in the absence of both the Chairperson and the Vice Chairperson, members present shall elect from among themselves a member to preside over the meeting. The Vice Chairperson or the member so presiding the meeting shall have all the powers of Chairperson for that meeting.
- (f) A decision of the Executive shall be by resolution of the majority of members present; and, in the event of an equality votes, the Chairperson or member presiding shall have a

The National General Council casting vote in addition to his / her deliberative vote as member of the Executive Committee.

An extraordinary General Council Meeting may be called for (g) by the National Executive Committee provided that half of the membership of the National General Council demands so.

The National Executive Committee shall hold meetings at least Meetings of the *21*. (a) National Executive once every three months at such specific venues and times as deemed convenient. Committee

- (b) Such meetings shall be preceded by a seven days' notice.
- The quorum for such meetings shall be half of the (c) membership. In the event that quorum is not formed after sixty minutes from the advertised time, the meeting shall stand adjourned for four weeks; and if quorum is not formed by then, the members present shall form a quorum.
- (d) The chairperson shall preside over all meetings. In the absence of the Chairperson, the Vice Chairperson shall preside over the meeting; and in the absence of both the Chairperson and the Vice Chairperson, members present shall elect from among themselves a member to preside over the meeting. The Vice Chairperson or member so presiding shall have all powers of Chairperson for that meeting.
- (e) A decision of the Council shall be by resolution of the majority of members present; and, in the event of an equality of votes, the Chairperson or member presiding shall have a casting vote in addition to his/her deliberative vote as a member of the Council.
- Meetings of There shall be an Annual General Meeting of every section, 22. (a) region and zone separately once a year at such specific venues The Sections, and times as deemed convenient, to which representation of all **Regions and Zones** registered membership shall be made.
 - (b) Such meetings shall be preceded by at lease seven days' notice.
 - (c) In addition to members of the organization or Fellowship, interested persons and organizations may be invited to such meetings as observers.
 - (d) The quorum for the Annual General Meeting shall be half of the registered membership. If no quorum is formed within sixty

minutes of the commencing time, members present shall proceed with deliberations without making binding resolutions.

- (e) The Chairperson shall preside over all meetings. In the absence of the Chairperson, the Vice Chairperson shall preside over the meeting; and in the absence of both the Chairperson and the Vice Chairperson, members present shall elect from among themselves a member to preside over the meeting.
- (f) A decision of the meeting shall be resolution by the majority of the members present; and, in the event of an equality of votes, the Chairperson or member presiding shall have a casting vote in addition to hi/her deliberative vote as a member of the council.
- (g) An Extraordinary General Meeting may be called for by the sectional, regional or zonal committee, proved that half of the membership of the particular section, region or zone demands so.
- Branch 23. (a) There shall be an annual meeting for all members of every branch separately once in a year at such specific venues and times as deemed convenient, notice of which shall be given at least seven days in advance.
 - (b) The quorum of such meetings shall be half the registered membership. If the quorum is not formed sixty minutes after the commencing time, the Annual Meeting shall stand adjourned for two weeks the quorum is not formed, members present shall form a quorum and make binding decisions.
 - (c) There shall of necessity be either the branch patron/matron or senior friend in attendance.
 - (d) The presiding over and decision making process shall be as stipulated in section 21 (e) and (f).
 - (e) Any other meeting of the members of the organization which is not Annual Meeting shall be called an Extra Ordinary Meeting; ad such meeting may deal with matters directly related to an Annual Meeting.
 - (f) An Extra Ordinary Meeting shall be convened at the request of at least half of the membership.
 - (g) Meetings that are neither Annual Meeting or Extra Ordinary Meeting shall be called Branch Meetings which shall cater for regular operation of the organization of the Branch.

- (h) Branch activities shall necessarily abide by Objectives and Statement of faith of the organization, and shall necessarily include Bible studies, prayer and social services.
- Meetings of 24.(a)The branch committee shall hold its meetings at least once aBranchfortnight at such specific venues and times as deemed convenient

Committee

- (b) The quorum for such meetings shall be half of the membership. If after sixty minutes from commencing time the quorum is not formed, the meeting shall stand adjourned for seven days; and if the quorum is not formed after seven days, members present shall form quorum and make binding decisions.
- (c) The presiding over the decision making process shall be as stipulated in section 21 (e) and (f).
- *Discipline* 25. (1) Membership of both or either organization and/or committee may be frozen on grounds of:
 - (a) Failure to abide by the Statement of Faith and objectives of the organization; or
 - (b) Any act perceived to be contrary to the moral standards, or detrimental to the wellbeing of the organization.
 - (2) A member shall be dismissed from either the organization or any committee by the immediately responsible committee in consultation with either the senior friend in case of branch committee, or the immediately higher committee.
 - (3) Any disciplined member may have the liberty to appeal for revision of disciplinary measures to the immediately higher committee, provided that no appeal shall be made against the National General Council's decision.
 - (4) Disciplinary measures may include:
 - (a) Suspension for a specified period of time.
 - (b) Expulsion.
 - (c) Public confession and apology.
- Arbitration 26.(1) No member, associate, senior friend or committee of the Organization shall take the organization or any part of it before any court of law, while such a member, associate, or committee is still within the organization, on matters whose substance is a matter of the organization's operational principles.

(2) Staff in full employment shall be exempted from the constitutional requirements to section 26 (1)

PART V: TRUSTEES

Appointment of 27.(1) The Trustees	The organization shall have six trustees who shall be the legal overseers of the organization and shall hold office for a period of three years, after which they may be re-elected.			
(2)	All trustees shall be elected by the National General Council at the Council's Annual General meeting.			
(3) Ca	ndidates proposed for membership on the Trustees Board shall be only those who have confirmed willingness to serve.			
(4) All	the property of the organization shall be vested in the Trustees.			
Incorporation of 28. the Trustees	As soon as is practicable after being elected, the Trustees shall apply for the incorporation of the organization under the Trustees Incorporation Act (Cap. 5:03 of the laws of Malawi).			
Powers and Functions 29 of the Trustees	Subject to the general and specific guidance from the National General Council, the trustees Board shall have the power:			
(a)	To represent the organization before such other, churches, government and other local organizations.			
(b)	To enter into contracts and agreements for the furtherance of the organisation's objectives.			
(c)	To authorize the acquisition of all property, suitable sites and/or premises for the organizations as well as the Fellowship.			
(d)	To raise support for the organization and the fellowship.			
(e)	To borrow money from any person or Institution on such terms as may be mutually agreed.			
(f)	To appoint any subcommittee or subcommittees of the Trustees Board as may be deemed necessary.			

- *Indemnity of* 30. The Trustees shall be indemnified against any risk and loss out of the organization's property incurred in the execution of duties.
- *Meetings of 31.* (1) The Trustees Board shall hold meetings at least once every six *of the Trustees* months.
 - (2) Such meetings shall be summoned by the chairperson or secretary in writing at least twenty one days in advance.
 - (3) The quorum for such meetings shall be at least half of the members. In the event that quorum is not formed within forty five minutes from the scheduled time, the meeting shall stand adjourned for thirty days; and if again, less than half members turn up them members present shall form quorum and make binding decisions.
 - (4) In the absence of the Chairperson, the Vice Chairperson shall act as Chairperson, members present shall elect a member from among themselves to act as Chairperson.

Cessation and 32.	A vacancy on the Trustees Board shall arise on:

- (d) A member leaving the country
- (e) A member facing to attend three consecutive meetings of the Board without valid reason; and

- *Common Seal* 33.(1) The common seal of the organization shall, when not in use, be kept in a secure and safe place at the organization's National Secretariat and its key placed under the custody of the chairperson of the Trustees board or the General Secretary.
 - (2) The seal shall be affixed to all documents required by any written law, in the presence of not less than two Trustees.

PART VI: FINANCE AND PROPERTY

Funds and 34. (1) The organization shall keep or cause to be kept books of accounts and other records related to its funds.

- (3) The organization shall open and operate a suitable bank account or accounts in the name of the organization, into which all funds of the organization not immediately in use shall be deposited.
- (4) All Bank transactions involving the organisation's account or accounts shall bear the signatures of at least two signatories appointed by the National Executive Committee, one of whom shall be the Treasurer.
- (5) Books of accounts of the organization shall be kept at such a place as the National Executive Committee deem think fit, and shall be open for inspection by members of the organization.
- (6) All investments of the organization shall be in the name of the registered Trustees of the organization.
- *Audit* 35. (1) The books of accounts of the organization shall be subject to audit annually by an auditor specially employed to examine the accounts.
 - (2) The audited accounts shall be presented to the Annual General meetings of the National General Council submitted at least seven days in advance.
- Dissolution36If upon winding up or dissolution of the organization there remains,
property after, satisfaction of all debt and liabilities, any property,
whatsoever shall not be paid to or distributed among the members of
the organization but shall be given or transferred to an institution or
institutions to be determined by the members of the organization at
or before the winding up.

PART VII: CONSTITUTIONAL AMENDMENT AND INTERPRETATION.

Amendment 37.Subject to the general and specific directions of the National General
Council, on amendment shall be made to this Constitution unless:Constitution

(a) A motion to amend has been communicated in writing by the Secretary of the National Executive committee to all members of the National General Council at least thirty days in advance;

- (b) The motion has been assented to by not less than two-thirds of the present members of the national General Council; and,
- (c) The decision is made by the national General Council.
